

F-1 Visa Student Admission Checklist

Submit Online Application

- Identify the F1 Visa Eligible Degree program of study
- Visit **Gwinnett Technical College's Application** and select "Apply Now"
- Select Fall or Spring for your application term. *Limited exceptions for a Summer start may be considered on a case-by-case basis.*
- Pay the one-time \$25 non-refundable application fee

Document Submission Deadline

Submit Official Transcripts

Foreign transcripts must be translated and evaluated by a NACES certified evaluation company.

A list of approved evaluation companies can be found at: [NACES.org/members](https://www.naces.org/members)


- For High School Diploma or GED transcript:** Submit an **official document-by-document** translation and evaluation of your high school or GED transcript. Applicants who have earned an associate or bachelor's degree are not required to submit a high school diploma or a GED transcript.
- For Post-Secondary Degree:** Submit **official course-by-course** translation and evaluation of transcripts from post-secondary colleges, universities, and other institutions attended.

Ways to Submit Evaluations

Opened transcripts are considered unofficial and cannot be accepted.

Exemption Qualifications: Successfully completed degree level MATH and ENGL (with a grade C or better) at a regionally accredited post-secondary institution in the U.S.

Submit Proof of English Language Proficiency

Only if English is NOT the official language for your country of origin

Scores provided cannot be more than 2 years old by the date of submission.

- TOEFL IBT score: 72 or higher
- IELTS Overall Band Score: 6.5 or higher

Exemption Qualifications: Successfully completed ENGL 1101 with a grade of C or higher at a regionally accredited Post-secondary institution in the U.S., or qualifying SAT or ACT scores no more than 5 years old by the date of submission.

Submit F-1 Visa Documents with Supporting Documentation to

□ F-1 Student Information Worksheet

- **Students applying from outside the U.S.** must include a copy or picture of their unexpired passport's biographical page with the [F-1 Student Information Worksheet](#).
- **Current F-1 students seeking to transfer to GTC** must include a copy or picture of their passport's biographical page, latest visa used to enter the U.S., most recent I-94, and current I-20 (with a wet signature and date) with the [F-1 Student Information Worksheet](#). Please make sure to notify your current Designated School Official (DSO) of your intent to transfer to Gwinnett Technical College (GTC) before completing our admission process. GTC will not recommend reinstatement on a completed or terminated I-20. Once accepted to our college you will need to send a completed [F-1 Student Transfer In Form](#) to your DSO with a copy of your Gwinnett Technical College's acceptance letter for them to transfer your current I-20 to GTC.
- **Students in the U.S. seeking to change their current status to an F-1 status** must include a copy or picture of their passport's biographical page, latest visa used to enter the U.S., and current I-94 with the [F-1 Student Information Worksheet](#). Please be aware that people in the U.S. under a C status, D status, K status, S status or Visa Waiver may not apply to change their status to F-1.

□ F-1 Student Affidavit of Financial Support

- This document must include supporting documentation demonstrating that the student or their sponsor(s) can financially support the tuition, fees, and living expenses of the student for a full year or the entire length of the program, at least \$35,678.
- For students with dependents, documentation must show they have an additional \$5,000 for each dependent.

Acceptable documents include bank statements or official letters issued by a bank or financial institution.

Documents must be issued on official letterhead, in English, indicate amounts in U.S. Dollars (please also indicate the exchange rate used if a conversion of funds is needed), and contact information for agent issuing the document.

These documents cannot be **more than 3 months old** at the date of submission.
