



Respiratory Care Degree Application Instructions

Spring 2027 Cohort

Program Application Deadline: October 10, 2026

Complete the attached **Respiratory Care Degree** application form only if you are accepted into Gwinnett Technical College.

- Step 1:** Read the instructions and application requirements very carefully. This is a writable form and does not need to be printed out. Please save to your computer and type into the form and save it back to your computer once you have completed the application before you email the form and all required documents to healthapp@gwinnettech.edu. **If there is any missing information or documentation, we will reject your application. You will receive an email why your application and documentation was rejected. You will need to correct these items and return the application and all documentation.**
- Step 2:** Review your Gwinnett Technical College Transcript to confirm that all prerequisites are accurately reflected. This will be attached to your email with your completed application.

To review and save to your computer your Gwinnett Technical College academic transcript:

- Log on to gwinnettech.edu/dashboard/
 - User name: FLLLLLXXXX (F=first initial lowercase L=first 6 of last name lowercase XXXX= last four digits of student 900 number)
 - Password: Enter default (gtcmmddyy) or your customized password).
 - Click on "Ellucian Experience Banner"
 - Click on "Student Profile Info & Fees Tile"
 - Click on "Student Profile" located in tile
 - On left hand side of page select "Academic Transcript"
 - Select Transcript Level "All Level"
 - Click on Transcript Type - Unofficial Transcript
- When your transcript displays, click the "Print Icon" on the right hand side of the page. A print window will pop up, change the destination field, select SAVE AS PDF and save to your computer to attach to your email with your application.**

***NOTE FOR APPLICANTS EXPECTING TRANSFER CREDIT:** Applicants will need to be accepted into Gwinnett Technical College at least 4 weeks prior to the application deadline to ensure that transfer credits have enough time to be evaluated and transferred in. The official evaluation process does not begin until a student is accepted and can take between 4-6 weeks. Once the official evaluation is complete, the credits that have been accepted will be transferred in and will show on your Gwinnett Technical College Transcript.

Step 3: Complete the Respiratory Care Degree Application Form with all required information. Attach all required documentation to your email as separate documents.

Be sure to attach a copy of your current:

- Gwinnett Technical College unofficial transcript downloaded from gwinnettech.edu/dashboard/
- Driver's license (take a picture with your cell phone and attach as a JPEG).
- Permanent Resident Card - only if you are not a U.S. citizen.

Step 4: Submit your completed application packet to the email address HealthApp@GwinnettTech.edu before the application deadline of **October 10th**.

Your application packet will be reviewed by an advisor for accuracy and completion before being submitted for processing. Incomplete application packets will not be accepted.

If your prerequisite GPA is below 2.75 you are not eligible to apply to the Respiratory Care program. Also, if your cumulative GPA is below 2.0 you cannot apply to the Respiratory Care program. You must be in good academic standing. If we find any errors with your application or incomplete applications, you will be emailed that your application has been rejected, and you will need to reapply to correct any errors found.

The Respiratory Care program will email you 4-6 weeks after the application deadline of October 10th to notify you that you have been accepted or denied into the Respiratory Care program. Please start checking your student email account the day after the October 10th application deadline. Check your student email account every day, it could take several weeks to receive this email.

A student may retake a course, but only the most recent attempt will be considered in this **initial screening process**. **Note: The final selection process will include the prerequisite GPA calculation.**

- I understand this application, along with all course information and supporting documents (driver's license, Permanent Resident card, if not a U.S. Citizen) must be received by emailed to healthapp@GwinnettTech.edu by the program application deadline of **October 10th**. I also understand incomplete packets will not be considered.
- I understand courses from Area II, Area IV, and FYES 1000 (unless exempt) must be completed with a "C" or higher to meet graduation requirements. Students are strongly encouraged to complete FYES, a Humanities Elective, and an Area II core class prior to program start to meet graduation requirements.
- I understand that all prerequisites marked with an asterisk (*) above must have been completed within 5 years of the application deadline and all courses marked with two asterisks (**) must have been completed with 10 years of the application deadline. BIOL classes completed prior to Fall 2021 will be considered expired and CHEM classes completed prior to Fall 2016 will be considered expired. Expired classes must be retaken or an exemption exam passed within the current application cycle in order to apply. - I have attached an unofficial copy of my Gwinnett Technical College transcript which I have downloaded from gwinnettttech.edu/dashboard/ and I have confirmed that all courses and grades listed above are accurately reflected therein. I also do not have a transcript waiver on file with the college, all my official transcripts have been received.
- Please be aware that our partner clinical sites are requiring students to complete their COVID-19 vaccine series. Each clinical site reserves the right to deny a student entry based on their own policies and procedures. If a student does not have all required immunizations and tests, the student may have limited access to clinical sites, which may delay or prevent program completion. As a result, successful completion of the program may not be possible.
- I understand completion of prerequisite courses and meeting other minimum requirements does not guarantee selection to the Respiratory Care Degree program, as there are a limited number of seats available in the occupational and clinical courses. I understand candidate selection is based on a competitive selection process, which includes a prerequisite **GPA of 2.75** or higher.
